Ocean First Institute has been funded to provide a free microplastics monitoring programming in 6 counties within the Front Range region of Colorado. Participating high schools will monitor their local watershed by collecting water and sediment samples and filtering them to verify and quantify microplastics. Additionally, students will learn how they can prevent microplastics from entering their watersheds. A student summit in Spring 2022 will highlight student data reporting and presentations.
